

Acid resistant capsules



Certified vegan hard capsules with unique properties, which delay the release of their contents after being taken (clinically tested). Those capsules are comprised of the secondary plant compounds hydroxy-propyl methylcellulose (HPMC) and gellan gum. These promote digestion in the same way as fibre and are not absorbed by the body. Thanks to the use of plant compounds, they contain on average 6% less moisture than gelatine capsules.

As an alternative to the branded capsules with gellan, conventional acid-resistant capsules with pectin can be used. These also provide controlled dissolution, ensuring that the active ingredients get released and absorbed in the digestive tract.

- Improved stability for acid-sensitive, moisture-sensitive ingredients.
- Increased taste and odour masking of ingredients.
- Acid-resistant HPMC capsules are particularly effective for acid- and moisture-sensitive ingredients and improve stability and shelf-life.
- The capsules provide controlled dissolution, ensuring that the active ingredients get released and absorbed in the digestive tract.
- Ideal for protecting probiotics, enzymes and othersensitive ingredients.



The film is fed in via a roller mechanism and shaped into a precise stick shape. The sticks are filled from the filling container via a screw conveyor. In the same working step, the stick is then automatically closed with the longitudinal seal head system.




